RE: TOWN OF ONOWAY BYELECTION - NOTICE OF NOMINATION

In reference to the above matter, please be advised that as a result of a vacancy on municipal council a byelection has been called. At the November 7th, 2019 Council meeting, Council established Election Day as January 24th, 2020 and authorized the appointment of the Returning Officer.

Due to recent changes in the Local Authorities Election Act, the next step in the election process will be the nomination period. The nomination period is the time for those persons interested in forwarding their name for the position of Councillor to submit the required paperwork. Nomination is now open and will close on Friday December 13th, 2019 at 12 noon (6 weeks prior to election day). Completed nomination papers can be dropped off at the Town Office located at 4812 – 51 Street any time between now and noon on December 13th, 2019. As per Town of Onoway Bylaw 736-17 a deposit of \$50.00 must accompany the completed nomination form. The official *Notice of Nomination* (form 3) is copied on the reverse side of this letter for your reference.

If you wish to be a candidate for election in this byelection you are required to complete and submit both the *Nomination Paper and Candidate's Acceptance* Form (form 4) and the *Candidate Information Form* (form 5) to the Town office prior to 12 noon on Friday, December 13th, 2019. The referenced forms can be obtained from the Town of Onoway or by downloading and completing the online forms found at: https://www.alberta.ca/municipal-election-forms.aspx

If more candidates are successfully nominated than there are vacancies an election will be required. If an election is required, the appropriate notice of this will go out in due course to keep the electorate informed and engaged.
