TOWN OF ONOWAY BUSINESS LICENSE MANDATORY STARTING 2020

In 2019 the Town of Onoway implemented a business license requirement which included a \$50.00 business license fee. This fee was waived for the 2019 year. To date, we have had 34 businesses who registered during our 2019 campaign. As 2020 is upon us, it is time now for all businesses operating within the Town of Onoway to register for their 2020 license. We are asking all businesses, including non profits, to register so we can maintain a current list of businesses and non profit groups operating within our Town. An important consideration of this list is that it will enable the Town to maintain an up to date contact list for emergent and/or urgent purposes, or may be referred to by Town personnel while carrying out regular Town business.

For 2020, your business license will serve as a regional business license and will be valid both within Lac Ste. Anne County and the Town of Onoway. As part of our regional economic partnership initiative with the County, a business directory will be maintained and promoted within our region. Other exciting regional economic initiatives are being developed with the County, and we look forward to their roll out as we move forward in 2020.

If you received a Business License in 2019 the Town will be forwarding you a renewal notice. If you did not receive a Business License in 2019 please forward a completed application along with your \$50.00 fee to the Town office. Business License application forms are available on our website at www.onoway.ca or you may stop by the Town office.

A Business License Certificate will be issued annually to be displayed within your business.

Business Licenses will be renewed on an annual basis.


This event may or may not be rescheduled. Town of Onoway Public Works will still be offering a Christmas tree pick up service on January 7 and 8 during business hours.

FIRES CAN HAPPEN! ARE YOU COVERED!

Did you know that the cost of fire suppression by the fire department for structure, grass or vehicle fire or home alarm is payable by the property owner? In our region, we have seen structure fires as high at \$28,000 and wildland fires as high as \$12,000.

- Be sure to check your home insurance policy or talk to your insurance agent about what exactly your policy covers and how much it covers
- Besides inquiry about your home structure fire insurance, we encourage you to have a conversation with respect to wildland insurance (a grass fire that could happen that never reaches a building).
- Be advised that should the fire department be dispatched to your residence as a result of a home alarm, a false alarm or, for example, a passerby sees smoke and calls 9-1-1, you, as the property owner, will receive an invoice for these call outs.
- If the fire department is dispatched to assist Alberta Health Services with respect to a medical call you will not be invoiced. This is a free service, within the Town of Onoway, provided by North West Fire Rescue through Onoway Regional Fire Services.
