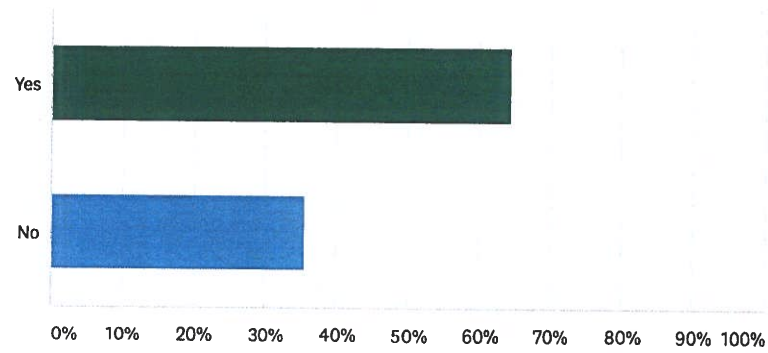


TOWN OF ONOWAY SURVEY - POTENTIAL MANDATORY FACE COVERING BYLAW

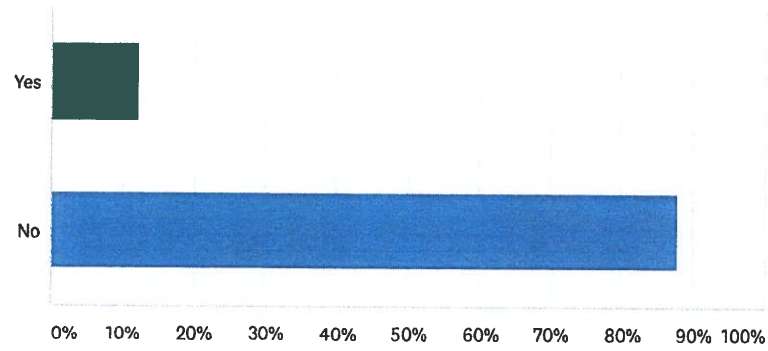

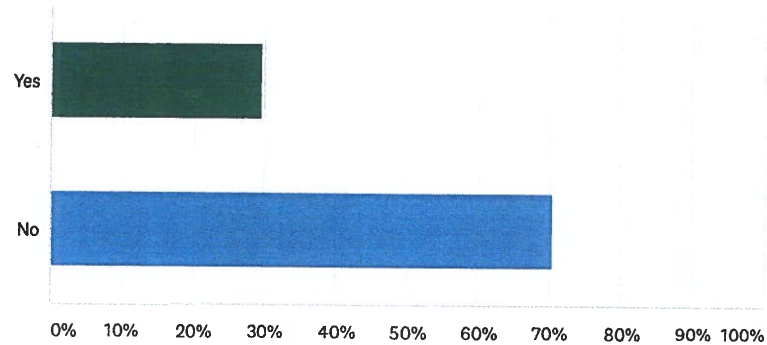

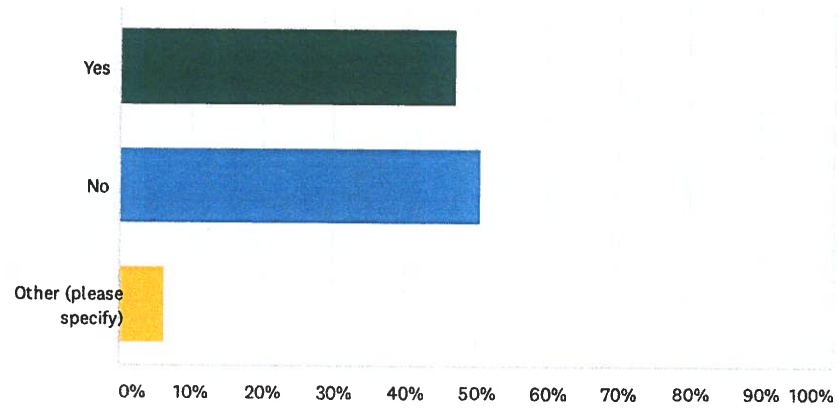

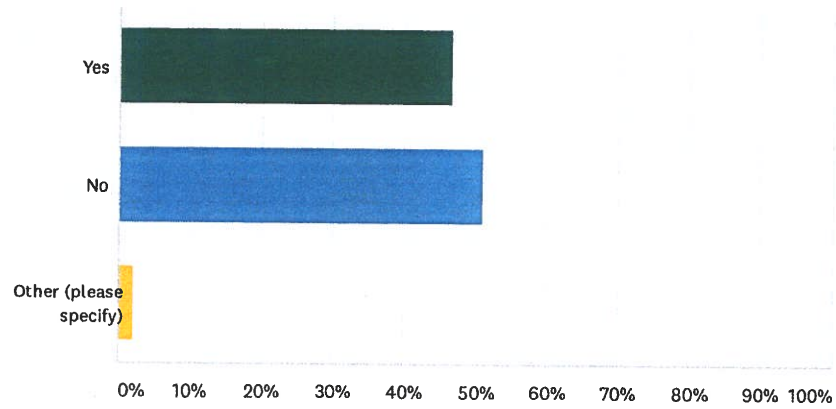

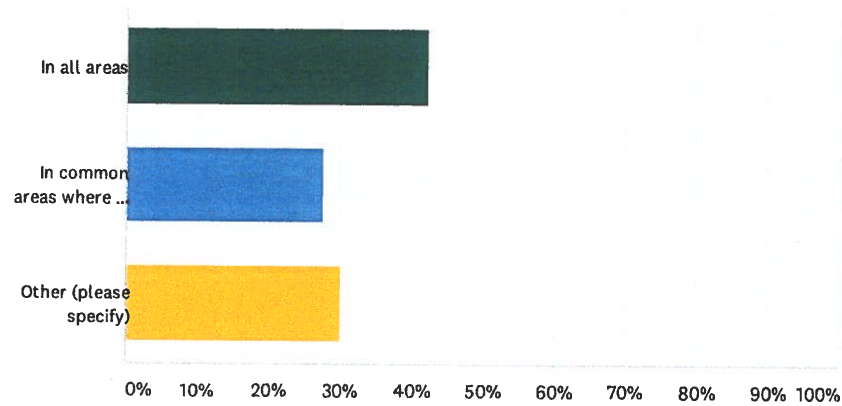

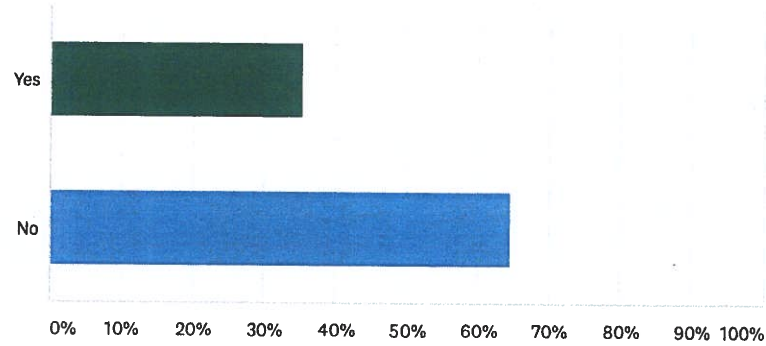
