### **BACKGROUND / PROPOSAL**

On September 28, 2022 the Town of Onoway received a request for a letter of support from Lac Ste. Anne County (attached) in regard to an application through the Alberta Crime Prevention Grant for a position that may be titled Community Crime Prevention Officer.

The application deadline was September 30, 2022

### What the grants are for

Grants from \$25,000 to \$150,000 per year (2022-23 and 2023-24) are available for Alberta-based programs or projects that:

explore or use innovative, promising or proven crime prevention practices enhance or create prevention activities for people at risk of becoming involved in criminal activity prevent crime or add public safety measures for vulnerable people or communities targeted by crime strengthens or adds capacity to an existing program or initiative.

Examples of programs, projects or initiatives include:

direct delivery of programs for crime prevention or community safety and well-being services or supports direct delivery of youth gang prevention and exit programs, services or supports activities to build the skills, knowledge and resources or capacity of an organization or community so they can deliver crime prevention or community safety and well-being programs like: development and delivery of information, training and resources or tools public education and awareness one-time initiatives addressing new issues and trends in crime prevention implementation of a public or community safety plan including training and equipment.<sup>1</sup>

### **DISCUSSION / OPTIONS / BENEFITS / DISADVANTAGES**

The Town of Onoway would benefit from a position being created in Lac Ste. Anne as there will be crime prevention initiatives and the position would act a liaison between agency stakeholders.





Alberta generates substantial volumes of agricultural and energy products. CN also handles growing amounts of intermodal container traffic through our Edmonton and Calgary terminals. In Edmonton, where almost 2,000 CN railroaders live and work, we have automotive distribution and CargoFlo® bulk handling facilities as well as metals and forest products distribution centres. In Calgary, you'll find our logistics park, automotive and forest products distribution centres, and a CN CargoFlo® bulk handling facility. Edmonton and Calgary are also home to major rail classification yards. CN maintains large railcar and locomotive repair shops at Edmonton's Walker Yard. In Fort McMurray, there's a second metals distribution centre and a third CargoFlo® facility. We also have another CargoFlo® facility and a forest products distribution centre in Edson.

### Network Investments

Since 2017, CN has invested about \$1.4 billion in Alberta to enable sustainable growth, improve capacity and advance the Company's commitment to safety. In 2022, we plan to invest \$365 million. Expansion projects include double-tracking sections of the Edson Subdivision as well as extending two sidings and replacing the Beverly Bridge on the Wainwright Subdivision. The maintenance program will focus on the replacement of 45 miles of rail and 70,000 ties, plus maintenance of 56 public crossings, as well as bridges, culverts, signal systems and other track infrastructure.

ALBERTA COUNCIL OF WOMEN'S SHELTERS ACWS develops leading-edge support tools for women's shelters and calls on the public to take action against domestic violence. CN sponsored their "Breakfast with the Guys" fundraising event.

ARTS ON THE AVE EDMONION SOCIETY Arts on the Ave believes in cultivating artistic fellowship through arts celebrations, signature art festivals, and traditions. The Society's goals are to create opportunities for all individuals to experience the joy of artistic expression and to nurture creative environments. CN supported Wasaka – A Celebration of Our Indigenous Heritage.

As I continue visiting Albertans across the province, I enjoy hearing what you think is going right in our health care system and what isn't.

I'm most encouraged by the ideas and solutions being brought to the table by

each participant that might improve our system.

I'm bringing senior staff from my department and AHS to communities around the province to hear what Albertans need from their healthcare providers and

how we can make it happen. We're already working on some specific suggestions.

Over the past few weeks, I met with healthcare workers and community leaders from Bassano, Claresholm and Cardston, as well as in Stettler, Rimbey and Olds. I'm also meeting with many other municipal leaders from across Alberta during the Alberta Municipalities conference. Their insight will significantly add to the feedback we are gathering on this province-wide tour. While many of these areas have very similar issues, the solutions to fix them can often vary.

One thing I am hearing is that people, especially rural Albertans, want more local-decision making; they understand the value of an integrated system that manages on the scale of the whole

province, in areas like procurement and basic standards for quality and access. But exactly how to manage services in Lethbridge or Whitecourt or Cardston has to be decided by people in Lethbridge and Whitecourt and Cardston, and it's not going to be the

same as in Edmonton or Calgary. So we need to get the balance right between local and provincial decisions.

A related question is about the funding and management of primary care, including the Primary Care Networks. We need to increase access to family physicians and primary care everywhere,

especially in smaller communities; the PCNs are a great platform to do that. We need to reinvest in the PCNs and in primary care generally. We need to get the balance right between provincial goals and standards and room for local initiatives to meet local needs.

To inform the necessary changes, 1 announced the forming of Expert Panels for Modernizing Alberta's Primary Care System (MAPS). These experts

will provide valuable insight from across Alberta, Canada, and the world on how we might be able to provide better preventative health care and ease the extraordinary burden that is on our acute and emergency health care systems. The goals of the panels are to help ensure access to quality,

timely, and appropriate care options that provide seamless integration to other health, social, and community services.

### AHS, AUPE-GSS reach new four-year agreement

Alberta Health Services (AHS) and the Alberta Union of Provincial Employees (AUPE) – General Support Services (GSS) have ratified a new collective agreement.

The four-year agreement expires on March 31, 2024, and sets out the terms and conditions for over 32,000 healthcare workers. The new collective agreement includes increases totaling 4.25 per cent over the length of agreement and a one per cent COVID-19 recognition payment for the calendar year of 2021. In addition, AHS and AUPE-GSS have agreed to partner on work to address recruitment and retention to remote and rural communities.

# Leading-edge cardiac procedure hits milestone

A team of Edmonton cardiac experts is celebrating a milestone a dozen years in the making: 1,000 patients in the city have undergone a leading-edge cardiac procedure known as TAVI.

Transcatheter aortic valve implantation, or TAVI, is used to treat patients with severe aortic stenosis, which blocks the aortic valve of the heart causing shortness of breath, chest pain, dizziness, fatigue, and can be fatal if left untreated.

Doctors insert a manufactured valve through a catheter inserted into a blood vessel and into the heart, replacing a patient's failing aortic valve.

In Edmonton, the TAVI procedure was first performed in 2010. It is a treatment option for patients for whom traditional open-heart surgery is deemed too risky.

### Three new physicians recruited to North Zone

Residents in two northern Alberta communities now have improved access to primary care with the recruitment of three new family doctors.

In Wabasca, Dr. Mohammad Khan began practising at the Bigstone Wabasca Medical Clinic this past May, and Dr. Glory Chukwuma began practising at Wabasca-Desmarais Health Care Centre and the Golden Opportunity Medical Clinic this past June.

In Whitecourt, Dr. Osayande (Tesh) Oteghekpen is providing care at Life Medical Clinic.

All are accepting new patients.



### Change to help Cold Lake physician availability

Health Minister Jason Copping has changed the designation of the Cold Lake Healthcare Centre in an effort to reduce disruptions to patient care caused by physician unavailability.

The facility's designation is being changed from rotation duty (because it exceeds 25,000 annual visits) to callback.

This change will enable Cold Lake physicians to receive a callback fee for emergency work, which is expected to improve physician recruitment and retention in the community. Eleven other AHS sites with 25,000+ visits are also designated callback facilities.

"The TAVI procedure doesn't require a sternotomy, it doesn't require an ICU stay or lengthy hospitalization, the risk of stroke is lower. Overall, it's amazing technology," says interventional cardiologist Dr. Benjamin Tyrrell.

"TAVI patients can resume normal activities within days, with no need for rehabilitation therapy. It eliminates a huge strain on the patient and their families, and on the healthcare system."

This past spring, Rick Kilbourn became the 1,000th patient to undergo

the TAVI procedure in Edmonton. He had open heart surgery to replace a valve in 2004. When that valve started to fail, his doctor recommended a TAVI procedure.

Kilbourn was released from the hospital the same day he had his TAVI procedure. He says his recovery has been significantly easier than recovering from open heart operation.

"It was unbelievable," Kilbourn says.
"I can't believe what doctors can do
these days."

# Annual cancer surgery numbers are up


### 12.5 per cent increase over pre-pandemic levels

Alberta's cancer surgery program is operating at nearly 115 per cent of pre-pandemic surgical volumes, with a larger proportion completed within a clinically appropriate time frame.

In the 2021-22 fiscal year, Alberta Health Services (AFIS) completed about 22,500 cancer surgeries, and 70 per cent of those were completed within clinically recommended wait times.

The number of surgeries represents a 12.5 per cent increase over pre-pandemic levels, when AHS completed 20,000 cancer surgeries (approximately 60 per cent within clinically recommended wait times) in 2018-19.

"Cancer treatment and care remains one of our highest priorities, and these procedures were prioritized throughout the pandemic to make sure that those who have the most urgent need go first," says Dr. Lloyd Mack, Medical Lead for Cancer Surgery Alberta.

The Calgary Cancer Centre is more than a new facility; it represents a new, integrated approach to cancer care, according to the medical professionals who will work there. Construction on the \$1.4-billion centre is expected to be complete this year, with the first patients welcomed next year.

### Staff, hours added in Okotoks, Chestermere

Alberta Health Services Emergency Medical Services (AHS EMS) has added additional paramedic staff and increased ambulance hours to better serve patients in Okotoks and Chestermere.

Ambulance coverage in both communities will now be available, locally, 24 hours daily. Previously, ambulances from surrounding areas have served the community outside of coverage hours.

As of Aug. 15, eight new paramedics have started working in Okotoks and Chestermere. This additional

suburban coverage is being bolstered by nine additional ambulances that are now serving patients in Calgary and Edmonton, helping to relieve some pressure on EMS, and reducing demand on EMS support from neighbouring communities.

"We've been steadfast in our goal of adding capacity to the system," says Darren Sandbeck, Chief Paramedic and Senior Provincial Director, AHS EMS.

These ambulances have been funded through \$16 million included in the current Government of Alberta budget.

### Airdrie urgent care resumes 24/7 coverage following recruitments

The urgent care centre at the Airdrie Community Health Centre resumed 24/7 hours of operation in August following the recruitment of four new physicians.

Additionally, more than \$1 million in new funding will add staffing and three new care spaces to further improve and enhance urgent care services in Airdrie. The community's urgent care centre currently sees and cares for between 130 and 140 patients every 24 hours. The addition of the three new care spaces will bring the capacity to 16 treatment spaces.

# More surgical options coming for Albertans

As part of the Alberta government's commitment to expanding healthcare system capacity and provide Albertans with better value for their healthcare dollars, Alberta Health Services (AHS) has invited chartered surgical facilities in central and southern Alberta to submit proposals to support additional surgeries, The contracts would increase capacity for hip, knee and other general surgeries to include 1,350 more surgeries in AHS Central Zone and another 1,250 more in the South Zone.

Chartered surgical facilities are public healthcare. The province pays for the procedures and they follow the same safety and professional standards as any hospital. Chartered surgical facilities have been offering publicly funded surgeries since the 1990s in Alberta. Now, more provinces are making use of chartered facilities in their communities to deal with ballooning surgery wait times after the pandemic. Twenty per cent of surgeries in Alberta were performed in chartered facilities in 2021–22 — that's about 55,500 surgeries.

This boost means many Albertans will be able to receive publicly funded surgeries closer to their home communities, which could include locations such as Red Deer in the Central Zone, and Lethbridge and Medicine Hat in the South Zone. Moving more of the orthopedic and other general surgeries into chartered surgical facilities will free up operating room space in hospitals to provide more complex surgeries.

Main operating room surgical suite hours have been increased at hospitals. Budget 2022 provides \$133 million over three years to expand and build new operating rooms in hospitals across the province, including in Calgary, Edmonton, Edson, Grande Prairie, Lethbridge, Medicine Hat and Rocky Mountain House.

# Stabilizing, strengthening primary healthcare

Alberta should be a place where access to a family physician or primary health care provider should be available to anyone who needs it, no matter where they live in the province. To achieve this, we need to look at modernizing primary healthcare and easing pressures on our hospitals as we emerge from the pandemic. This is why we are introducing Modernizing Alberta's Primary Health Care System (MAPS).

Making meaningful change starts with bringing Alberta's primary healthcare leaders and national and global experts together to identify immediate and long-term improvements to strengthen the primary healthcare system.

Three advisory panels have been tasked with the initial piece of work that will identify primary healthcare improvements in the short-term as well as over the next five to 10 years.

A Strategic Advisory Panel made up of local primary healthcare leaders, patients

and experts will recommend an overall strategy to improve primary healthcare. An International Expert Panel made up of national and international experts will inform the work of the Strategic Advisory Panel. An Indigenous Panel of Indigenous health experts will ensure Indigenous voices and wisdom are integrated into the initiative.

MAPS will have a particular focus on addressing challenges Indigenous and rural Albertans face when trying to find a family doctor or other primary healthcare provider.

Working closely with the Alberta Medical Association, Primary Care Networks (PCNs) and other primary healthcare leaders across the province, the panels will address major issues, identify key areas for improvement, and recommend both new opportunities and ways to ramp up existing strengths in the system. A final report with a recommended strategies will be finalized in spring 2023.

### Priority: Rural Engagement and Initiatives

This work is designed to strengthen partnerships with rural communities, to enhance and better support the rural healthcare workforce, and to better meet the unique needs of Albertans living in non-urban communities.

### Minister, AHS leaders tour continues

AHS leadership continues to join Health Minister Jason Copping at a series of engagement events this month and into October. In each community, events are being hosted for internal and community stakeholders who discuss three key questions:

- · What is the healthcare system doing well?
- · What are the current challenges within the healthcare system?
- · What opportunities exist to address challenges?

Events were held this month in Bassano, Cardston, Claresholm, Stettler, Rimbey and Olds. Additional sessions are being held in Calgary, Airdrie, Red Deer, Edmonton, Canmore and Camrose.

A key takeaway from all the events to date has been appreciation for the staff at AHS facilities. Internal stakeholders praise their colleagues for their dedication, and community stakeholders consistently speak of the excellent care they receive when in an AHS facility, or accessing an AHS program or service.

All participants continue to raise shortages of physicians and front-line caregivers as a key challenge impacting service delivery. Overall, about 700 Albertans have participated in engagement sessions to date.

### **Priority: Alberta Surgical Initiative (ASI)**

The ASI will improve timely access to surgical care in Alberta. The goal of ASI is to ensure adult and pediatric patients receive scheduled surgeries within clinically appropriate timeframes.

### Surgical wait-list status update

We continue to work diligently to recover to pre-pandemic surgical status. Over the past four weeks, the average weekly volume for surgical activity is 98% of our pre-pandemic surgical volumes. The surgical wait list for adults sits at approximately 73,550, compared with about 68,000 in February 2020, before the pandemic. Approximately 111,000 surgeries have been completed in the 2022/23 fiscal year.

#### Surgical wait-list management project

AHS continues to conduct a surgical wait-list validation project across the province. Through September, patients listed for surgery will receive a phone call, voicemail or automated call from the AHS surgery wait-list management team.

As part of the process to confirm wait-list status, patients will be asked for their provincial personal health number and birthdate to confirm their identity. Patients who hang up or do not call the number back will not see their position on the wait-list affected.

AHS will never ask for financial information or for any personal information other than the patient's provincial personal health number or birthdate during these automated calls. To help patients determine that the call is not a scam, a <u>webpage</u> has been created outlining the scripts being used for each zone. If patients have further questions about their surgery, they are encouraged to contact their surgeon's office.


### Fallen EMS Colleague Mourned

This past Wednesday, EMS colleagues said goodbye to one of their own: advanced care paramedic Dallas Boyko. Dallas was given full EMS honours in a procession that brought together more than 1,000 colleagues and members of the first responder community from EMS, police and fire, from across the province and the country, including representatives from B.C., Ontario, Quebec and New Brunswick. This was followed by a memorial service with her family, colleagues and many members of the community whose lives were touched by Dallas.

Throughout her distinguished 25-year career, Dallas treated thousands of patients with tremendous courage, compassion and skill. She mentored and precepted hundreds of students and new staff, and made dozens of close friendships throughout her time with Associated Ambulance, Parkland Ambulance and AHS.

As a sign of her tremendous dedication and service, Dallas was awarded the 12-year provincial service medal, in addition to countless commendations from patients, families, peers and supervisors. EMS is incredibly grateful for Dallas's many years of service and we share our deepest condolences with her family, friends, colleagues and all who knew her, on this unimaginable loss. ### Obstetrical services pausing at Westlock Healthcare Centre

AHS is temporarily pausing obstetrical services at the Westlock Healthcare Centre until October 31, 2022. The decision is centered on patient safety and is due to a lack of trained registered nurse availability. Local physicians will continue to provide care to current and future obstetrical patients until the late stages of pregnancy, before transitioning their care to another physician who will support their delivery.

### Follow-up testing recommended for former clients of private midwifery services provider

AHS is seeking to notify all individuals who were clients of the Calgary Midwives Collective (CMC) between 2013 and March 2022 of a potential risk of exposure to hepatitis B due to improperly sterilized medical equipment.

While the risk to clients is considered very low, AHS is advising all individuals who received prenatal, delivery and/or post-natal care services through the CMC to call their physician to arrange for simple, confidential testing. Potentially affected individuals may also call Health Link at 811 on a 24/7 basis to arrange testing, or with any questions or concerns.

The CMC operated at 306, 1010 1 Ave. N.E., in Calgary. As this midwifery practice is no longer operational, there is no ongoing risk to the public.

### Interim CEO Video Message: Spotlight on Environmental Public Health

### Precautions Can Help You, Others Stay Healthy

As we enter respiratory virus season, here are a few simple reminders to help ensure you, your families and all Albertans stay as healthy as possible in the coming months.

#### AHS Completes Addition of 50 New ICU Beds

Work is now complete to add 50 additional, fully staffed intensive care unit (ICU) beds in hospitals across the province. Alberta now has 223 adult general ICU beds, a 29 per cent increase from before the pandemic. AHS has opened the additional beds in every region, using a phased approach, with the support of a \$300-million investment over three years from the Government of Alberta.

#### Of the 50 new ICU beds:

- Eighteen are in the Edmonton Zone: University of Alberta Hospital, Royal Alexandra Hospital and Sturgeon Community Hospital.
- Thirteen are in the Calgary Zone: Foothills Medical Centre, Peter Lougheed Centre, Rockyview General Hospital and South Health Campus.
- · Eight are in the Central Zone's Red Deer Regional Hospital Centre.
- · Six are in the South Zone's Chinook Regional Hospital.
- Five are in the North Zone: Grande Prairie Regional Hospital and Northern Lights Regional Hospital.

The surgical wait list for adults sits at approximately 72,800, compared with about 68,000 in February 2020, before the pandemic. Approximately 122,500 surgeries have been completed in the 2022/23 fiscal year.

#### Surgical Wait-list Validation Project Expands

AHS is expanding a wait-list validation project into Central Zone to manage the surgical wait-list across the province. With this launch, all zones are now conducting this surgical wait-list confirmation work.

Patients listed for surgery will receive a phone call, automated call or voicemail. As part of the process to confirm wait list status, patients will be asked for their provincial personal health number and birthdate to confirm their identity. Patients who hang up or do not call the surgical wait-list team back will not see their position on the wait-list affected.

Patients are reminded AHS will never ask for financial information or for any personal information other than your provincial personal health number or birthdate during these automated calls. To help patients determine that the call is not a scam, a <a href="webpage">webpage</a> has been created outlining the scripts being used for each zone.

#### Alberta Medical Association, Alberta Health Ratify New Agreement

Last week the Government of Alberta announced a new agreement with the Alberta Medical Association (AMA) has been ratified by physicians throughout the province. The agreement will mean an investment of about \$750 million in new funding over four years to stabilize the healthcare system. This includes more than \$250 million in targeted funding to address pressures, including recruitment and retention programs, so more Albertans can access family doctors, and more support for practice viability.

This half-day session provides important status updates to operational leaders (zone, provincial programs, and site leadership, as well as implementation teams, managers, directors, and physician leads), from Connect Care project teams as they prepare to launch,

#### In-hospital Labs to Shift to Hospital Patients Only on Dec. 5

Several in-hospital labs will shift their focus to the needs of emergency, inpatient and ambulatory patients, and will direct community patients to labs in the community beginning December 5. This change is being implemented only in areas where community lab collection sites are already operating. In most cases, the nearest community site is within two kilometres of an acute care centre. These include labs at:

- · East Edmonton Health Centre
- · Fort Saskatchewan Community Hospital
- Grey Nuns Community Hospital
- Leduc Community Hospital
- Misericordia Community Hospital
- Northeast Community Health Centre



This is one step towards the larger transition of community lab services from Alberta Precision Laboratories (APL) to DynaLIFE Medical Laboratories. By transitioning community lab services to DynaLIFE, APL will be better able to maintain lab quality and provide a more efficient, effective and sustainable laboratory system that supports Alberta's ever-growing demand for lab testing.

#### **New Ambulances Serving Patients in Calgary and Edmonton**

AHS has 10 additional net-new ambulances in service for Alberta patients, with five each in Calgary and Edmonton. These new ambulances are helping to relieve pressure on EMS and improve access to emergency patient care.

These 10 new ambulances are in addition to nine net-new ambulances that went into service in June 2022, for a total of 19. They have been funded through \$16 million included in the current Government of Alberta Budget, and are one component of the AHS EMS 10 Point Plan to address sustained high call volume and ensure Albertans get emergency care where and when they need it.

EMS has experienced a sustained increase in 911 call volumes of up to 30 percent above pre-pandemic levels, and call volumes have increased nearly 60 percent since 2010. All call types have increased and staff illness and fatigue continue to contribute to challenges in the healthcare system.

To staff these new ambulances, AHS has also hired new paramedics to provide patient care. These 40 new Primary Care Paramedics – 20 each in Calgary and Edmonton – augment an additional 40 paramedic positions that AHS EMS hired in the spring of 2022. #### New Screening Program Will Use CT Scans to Detect Early-stage Lung Cancer

AHS has launched the Alberta Lung Cancer Screening Program (ALCSP), a new two-year pilot project that will offer lung cancer screening using low-dose computed tomography (CT) scans to approximately 3,000 eligible Albertans.

Lung cancer screening is for individuals who are at a high risk for lung cancer. Albertans may be eligible for screening if they are between the ages of 50 and 74, smoke cigarettes, or quit after smoking for many years, and are a patient within one of three Primary Care Networks (PCN) – the Mosaic PCN (Calgary), the Edmonton O-day'min PCN, and the Grande Prairie PCN. These locations were chosen for this initial pilot based on high smoking rates and population demographics. Eligible patients can be referred to the program by a primary care provider from one of these three participating PCNs.

One in 13 Albertans will develop lung cancer in their lifetime, and more than 1,500 will die each year as a result. However, for high-risk Albertans with no symptoms, getting screened regularly can lower the risk of dying from lung cancer by almost 25 per cent. Although smoking is not the only risk factor – radon gas, asbestos, and outdoor air pollution are also risks – cigarette smoking is the cause of 8 out of 10 cases of lung cancer.

This pilot project is funded through AHS and the Canadian Partnership Against Cancer (CPAC). CPAC has made an initial investment of \$5.0 million to accelerate planning and implementation in jurisdictions across Canada. #### **Edmonton Cardiac Program Reaches Milestone**

A team of local cardiac experts is celebrating a milestone a dozen years in the making: 1,000 patients have undergone a leading-edge cardiac procedure known as TAVI here in the city. Transcatheter aortic valve implantation, or TAVI, is used to treat patients with severe aortic stenosis, which blocks the aortic valve of the heart causing shortness of breath, chest pain, dizziness, fatigue, and can be fatal if left untreated. Doctors insert a manufactured valve through a catheter inserted into a blood vessel and into the heart, replacing a patient's failing aortic valve.

In Edmonton, the TAVI procedure was first performed in 2010 by a team comprised of cardiac experts

open heart surgery.

Patients across Alberta have benefited from TAVI. Since 2011, teams at the Foothills Medical Centre in Calgary have also performed the TAVI procedure. #### **Daily Fit for Work Screening Update**

AHS has updated our <u>Fit for Work</u> screening to align with Ottawa's removal of COVID-19 entry requirements. Note the travel question has been removed from the Fit for Work screening tools. Staff, physicians, volunteers, students, vendors and contractors must still comply with the screening requirements established in their workplace.

As we live with COVID-19 and head into the respiratory illness season, workers must continue to follow safety measures including proper hand hygiene, PPE, social distancing where possible, immunization and staying at home when sick to keep everyone safe.

#### Interim CEO Video Message: Preparing for Influenza Season

Flu season is upon us again, and this year will be the first time both influenza and COVID-19 are circulating in our communities with no public health restrictions. It's important we all continue to take the required precautions to reduce the spread of influenza. By keeping the number of influenza cases and outbreaks low, we can help protect our patients, as well as the more vulnerable populations such as seniors and young children.

Immunization is the most effective way to prevent infection, and to limit the spread of the virus to those around you. We encourage you all to take action and get the flu shot this year.

#### Bivalent Vaccine Now Available Province Wide for Eligible Albertans

The Moderna Bivalent BA.1 vaccine is now available province wide as an additional booster dose option for Albertans 18 years of age and older.

Albertans are encouraged to receive their Bivalent BA.1 vaccine booster dose at a pharmacy. If their local pharmacy is not listed in the booking system, Albertans can contact the pharmacy directly or visit Alberta Blue Cross to find a pharmacy near them offering this vaccine option. Appointments may also be available at AHS clinics and can be booked online or by calling 811.

We encourage all staff to get their influenza immunization and — if they are eligible – a COVID-19 bivalent booster dose at the same time. Health Canada approved Pfizer's new bivalent COVID-19 vaccine October 7, which will be eventually offered at WHS clinics along with the Moderna bivalent product that will be available as soon as the WHS immunization clinics commence next week.

It is recommended to wait at least five months after last dose, and at least five months after a COVID-19 infection before receiving the Bivalent BA.1 vaccine booster dose. This vaccine triggers a stronger immune response and provides additional protection against both Omicron and the original SARS-CoV-2 virus strain.

#### **Exercise Caution in Common Areas**

Many individuals are returning to AHS sites either on a part-time or full-time basis, or to attend in-person meetings. When using common spaces such as break rooms, meeting rooms, or washrooms, these simple practices can help ensure the health and safety of yourself, and others around you.

- · Continuously mask.
- · Practise hand hygiene.
- Be respectful of physical distancing requirements and the personal comfort of others.
- · Make virtual meeting options available.
- · Avoid attending in-person if you don't feel well.
- Regularly wipe down high-contact areas, such as doorknobs, drawer pulls, coffee pots and appliance handles.

While in common spaces, AHS staff can host and attend in-person meetings provided the above guidelines remain in place. Food may be consumed, provided all attendees continue to follow the guidelines in the <u>Decorations, Costumes, Food, Celebrations and Donations Information Sheet.</u> When consuming food and drink in a common meeting space, attendees may have their mask down provided there is adequate space to physically distance.

During an outbreak situation, facilities or units may add additional measures in common meeting spaces to ensure everyone's health and safety. Thank you for continuing to follow these guidelines as we enter the fall respiratory season and work to keep each other, and all Albertans, safe.





# Career Profile Diagnostic Sonographer

Diagnostic sonographers use high frequency sound waves to produce quality diagnostic images for a variety of ultrasound procedures.
Ultrasound technology safely and non-intrusively examines many parts of the body including organs in the abdomen, breast, uterus and ovaries, prostate gland, heart and blood vessels.

Diagnostic sonographers use their independent judgement and expertise to adapt and record the procedure as required. They write a preliminary interpretation of the procedure findings to the reporting physician, who in turn speaks with the patient.

Approximately a three hours' drive northwest of Edmonton, High Prairie is located within Alberta's Big Lakes County.

## Rural Engagement & Initiatives

This work is designed to strengthen partnerships with rural communities, to enhance and better support the rural healthcare workforce, and to better meet the unique needs of Albertans living in non-urban communities.

AHS leadership continues to join Health Minister Jason Copping at a series of engagement events this month and into October. In each community, events are being hosted for internal and community stakeholders who discuss three key questions:

- What is the healthcare system doing well?
- What are the current challenges within the healthcare system?
- What opportunities exist to address challenges?

A key takeaway from all the events to date has been appreciation for the staff at AHS facilities. Internal stakeholders praise their colleagues for their dedication, and community stakeholders consistently speak of the excellent care they receive when in an AHS facility or accessing an AHS program or service.

All participants continue to raise shortages of physicians and front-line caregivers as a key challenge impacting service delivery.

Overall, about 700 Albertans have participated in engagement sessions to date.

# How can community members help?

Physicians and staff choose a community, and stay, because it feels like home.

Once arrived, new physicians, staff, and their families need support and connection to settle into their new environment.

Many communities help new hires and their families find housing. RhPAP also runs a housing program that can accommodate families in the short term.

TO BUY OR TO RENT: THE HOUSING MARKET CONTINUES TO BE RESHAPED BY SEVERAL FACTORS AS CANADIANS SEARCH FOR AN AFFORDABLE PLACE TO CALL HOME

In 2021, 10.0 million households in Canada owned their home, which is more than at any point in the country's history. However, while the number continues to grow, Canadians overall were less



likely to own their home in 2021 (66.5%) than they were a decade earlier, when a record high (69.0%) were homeowners.

This follows a period of growth where the homeownership rate grew from 63.6% in 1996 to 68.4% by 2006......Read more

# INDIGENOUS POPULATION CONTINUES TO GROW AND IS MUCH YOUNGER THAN THE NON-INDIGENOUS POPULATION, ALTHOUGH THE PACE OF GROWTH HAS SLOWED

The 2021 Census counted 1,048,405 First Nations people living in Canada, marking the first time that the First Nations population surpassed the 1 million mark in a census.

While more than half (55.5%) of all First Nations people lived in Western Canada, Ontario had the largest number of First Nations people provincially (251,030), making up nearly one-quarter (23.9%) of the First Nations population in Canada. Meanwhile, one in nine First Nations people (11.1%) lived in Quebec, and 7.6% lived in Atlantic Canada. The remaining 1.9% of First Nations people lived in the territories.....Read more

# WHILE ENGLISH AND FRENCH ARE STILL THE MAIN LANGUAGES SPOKEN IN CANADA, THE COUNTRY'S LINGUISTIC DIVERSITY CONTINUES TO GROW

Despite the impact that the COVID-19 pandemic has had on arrivals to the country, immigration has continued to enrich Canada's linguistic diversity.

English and French remain by far the most commonly spoken languages in Canada. More than 9 in 10 Canadians speak one of the two official languages at home at least on a regular basis.

The 2021 Census also found that 4.6 million Canadians speak predominantly a language other than English or French at home (in other words, they speak this language most often at home, without speaking other languages equally often; see the box "Languages known and spoken: Understanding the concepts"). These individuals represent 12.7% of the Canadian population, a proportion that has been increasing for 30 years. By comparison, the proportion was 7.7% in 1991, when immigration levels were rising....Read more



# HOUSING CONDITIONS AMONG FIRST NATIONS PEOPLE, MÉTIS AND INUIT IN CANADA FROM THE 2021 CENSUS

Approximately one in six Indigenous people (16.4%, or 295,745 people) lived in a dwelling that was in need of major repairs in 2021, down 2.7 percentage points from 2016.



Dwellings in need of major repairs include those that require major repairs such as defective plumbing or electrical wiring and those that require structural repairs to walls, floors or ceilings. Although Indigenous people were almost three times more likely to live in a dwelling in need of major repairs (16.4%) than the non-Indigenous population (5.7%) in 2021, the gap narrowed by 2.3 percentage points from 2016... 



# 2021 CENSUS LINGUISTIC PORTRAIT OF ALBERTA





Indigenous mother tongue and Indigenous language spoken at home by gender
