

**TOWN OF ONOWAY  
BYLAW NO. 743-18**

**A BYLAW OF THE TOWN OF ONOWAY IN THE PROVINCE OF ALBERTA, FOR THE PURPOSE OF ESTABLISHING A FAMILY AND COMMUNITY SUPPORT SERVICES (FCSS) PROGRAM.**

**WHEREAS**, the Town of Onoway Council deems it expedient and proper to provide Family and Community Support Services to the municipality; and

**WHEREAS**, the Town of Onoway will administer the FCSS funds for the following municipalities: Alberta Beach, Summer Village of Birch Cove, Summer Village of Castle Island, Summer Village of Nakamun Park, Summer Village of Silver Sands, Summer Village of South View, Summer Village of Sunrise Beach, Summer Village of Sunset Point, Summer Village of West Cove, Summer Village of Val Quentin and Summer Village of Yellowstone.

**WHEREAS**, the Council for each of the participating municipalities will provide the Town of Onoway Administration and FCSS Coordinator with written confirmation of where, and in what amount, their FCSS funding will be expended.

**SECTION 1            TITLE**

1.            This Bylaw may be cited as "The Town of Onoway Family and Community Services Bylaw".

**SECTION 2            DEFINITIONS**

For the purpose of this Bylaw and in the Schedules attached hereto, unless the context otherwise requires:

- 2.1            **"Council"** means the municipal council elected in accordance with the Local Authorities Elections Act.
- 2.2            **"FCSS"** means Family and Community Support Services
- 2.3            **"FCSS Coordinator"** means an employee of the Town of Onoway employed to administer the FCSS Program for the Town of Onoway and participating municipalities.
- 2.4            **"Municipalities"** means Alberta Beach, Summer Village of Birch Cove, Summer Village of Castle Island, Summer Village of Nakamun Park, Summer Village of Silver Sands, Summer Village of South View, Summer Village of Sunrise Beach, Summer Village of Sunset Point, Summer Village of West Cove, Summer Village of Val Quentin and Summer Village of Yellowstone."

**SECTION 11            VALIDITY**

- 11.1            Bylaws 739-18 shall be rescinded in its entirety upon effective date of this bylaw.
- 11.2            That this Bylaw shall take effect on the 7<sup>th</sup> day of June, 2018.


